NOTICE is hereby given that at its regularly scheduled meeting on October 31, 2017, the Fresno County Board of Supervisors adopted Ordinance No. 17-018, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE
The Proposed Ordinance would (1) repeal
Section 2.28 059 of Chapter 2.28 of Title

The Proposed Ordinance would (1) repeal Section 2.28.059 of Chapter 2.28 of Title 2 of the Ordinance Code of the County of Fresno ("Ordinance Code"), which consolidated the Offices of the District Attorney and Public Administrator; (2) amend the title of Chapter 2.32 of the Ordinance Code to read "Sheriff-Coroner-Public Administrator"; and (3) amend Section 2.32.090 of Chapter 2.32 of the Ordinance Code to consolidate the Public Administrator with the Sheriff-Coroner's Office. The Proposed Ordinance would take effect and be in force thirty (30) days from and after its passage, but would not be operative as to the duties or salaries of the offices affected until the commencement of new terms of office in January 2019.
