12 opportunity to purchase one (1) pickup truck for use in weed management services on County roads
13 and property in the current year; and

14 WHEREAS, Ag, Org 40101012 also has funds available for the purchase of the pickup truck
15 in the amount of \$32,000; and

16 WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$32,000 as an Operating
17 Transfer In from Ag, Org 40101012 to purchase the pickup truck; and

18 WHEREAS, said monies are not included in the adopted appropriations and estimated
19 revenues for the FY 2017-18 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

20 WHEREAS, Section 615 of the Management Directives provides for the appropriation of
21 these funds by a four-fifths vote by the Board of Supervisors;

22 NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
23 is authorized to increase the appropriations in the FY 2017-18 ISD - Fleet Services Equipment Org
