WHEREAS, the County of Fresno, Public Works & Planning-Grants will receive \$502,000 from Special Revenue Fund 0086; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Public Works & Planning Organization 5512; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Public Works & Planning Organization 5512 as follows:




