WHEREAS, Research shows 44 percent of households lack savings to cover a \$400 emergency expense. Earned Income Tax Credits are often the largest cash infusion workers will receive all year, providing an essential financial cushion for those households living paycheck-to-paycheck. According to Bob Annibale, Global Director of Citi Community Development; and

WHEREAS, The United Way Free Tax Preparation services are being provided at eight sites throughout Fresno County in addition to being available at three mobile stops made by the Franchise Tax Board's bus in the City of Kerman Saturday April 7th from 10am to 3pm at the Kerman Community Center; in Huron April 14th from 10am to 3pm at the Huron Neighborhood Resource Center and in Mendota on March 10th; and

WHEREAS, Taxpayers can call 2-1-1 or 866-559-4211 to find out if they qualify and to schedule an appointment or alternatively file for free online at www.myfreetaxes.org.
