SUPERVISOR BERGEAS ASKED DAN CEDERBORG, COUNTY COUNSEL, IF IT IS CORRECT THAT CEREMONIAL ITEMS DO NOT NEED TO GO TO THE PUBLIC FOR PUBLIC COMMENT. COUNTY COUNSEL DAN CEDERBORG STATED THAT IT IS NOT REQUIRED FOR NON-ACTION ITEMS OF THE BOARD UNDER THE BROWN ACT, BUT TO RECEIVE PUBLIC COMMENT ON ANYTHING THE BOARD IS TAKING ACTION ON. HE REFERENCED A BOARD ADMINISTRATIVE POLICY THAT STATES A BOARD MEMBER HAS THE RIGHT TO PUT ONLY 2 ITEMS ON THE AGENDA, BUT THE BOARD BY MAJORITY VOTE CAN WAIVE ITS OWN POLICIES AND IT IS NOT A LEGAL REQUIREMENT. SUPERVISOR PACHECO STATED THAT THE BOARD SHOULD ADHERE TO ITS RULES REGARDING PLACING MATTERS ON THE AGENDA. SUPERVISOR BERGEAS REPORTED THAT HE ATTENDED A MEETING REGARDING A DISCUSSION OF THE PROPOSED LEGISLATION 3218 AND THE SAN JOAQUIN RIVER. HE ARTICULATED THE MEANING OF THE BOARD'S LETTER AT THE MEETING, STATING THAT THE BOARD'S POSITION IS THAT THE LEGISLATION SHOULD NOT RESTRICT THE STATUTORY JURISDICTION OF THE CONSERVANCY, SHOULD NOT RESTRICT PERFORMANCE OF THE CONSERVANCY'S MISSION AND SHOULD NOT RESTRICT LAND USE AUTHORITY OF THE CONSERVANCY, CITY OF FRESNO, COUNTY OF FRESNO OR COUNTY OF MADERA. SUPERVISOR MENDES STATED THAT THE DEPARTMENT OF WATER RESOURCES REPORTED THAT DUE TO MIRACLE MARCH ECHO SUMMIT'S SNOW PACT LEVEL IS AT 57% OF NORMAL. THEY FAILED TO REPORT THAT FOLSOM DAM STARTED FLOOD RELEASE ON MONDAY AND CONTINUED THROUGH TODAY SHOWING THERE IS NOT ENOUGH DAM CAPACITY IN THE STATE. SUPERVISOR MAGSIG REPORTED THAT SOUTHERN CALIFORNIA EDISON HAS RELEASED INFORMATION STATING THAT ALL LAKES IN EASTERN FRESNO COUNTY WILL BE FILLED AT DIFFERENT TIMES THIS YEAR AND THE RAIN AND SNOW ARE HELPING TREMENDOUSLY. SUPERVISOR MAGSIG ALSO STATED THAT IT IS ABSOLUTELY CRITICAL TO BUILD THE TEMPERANCE FLAT DAM AND THE BOARD IS SENDING A POINTED LETTER TODAY OPPOSING A BILL IN LEGISLATURE THAT WOULD SLOW DOWN, IF NOT STOP, THE PROCESS OF ALLOWING THE TEMPERANCE FLAT DAM TO BE BUILT BY CHANGING THE STATUS OF THE AREA WHERE THE DAM IS PROPOSED TO BE BUILT. CHAIRMAN QUINTERO ADVISED THAT SATURDAY, APRIL 7TH CALWA IS HAVING A COMMUNITY CLEAN UP DAY. THIS DAY INCLUDES PAINTING THE CALWA COMMUNITY CENTER AND CLEANING THE STREETS AND ALLEYS AND INFORMATION TABLES WILL BE SET UP BY THE COUNTY OF FRESNO LEAD BASED PAINT PROGRAM FOR HOMES AND THE COUNTY OF FRESNO ANIMAL CONTROL SERVICES. SEVERAL KIWANIS CLUBS ARE ASSISTING AND THERE ARE 150 VOLUNTEERS TO HELP ON THAT DAY
