WHEREAS, County Service Area 34 Zone D (CSA 34D) also known as Renaissance at Bella Vista, was formed on December 5, 2017 to provide various utility services to the community; and

WHEREAS, \$20,400 is available in the fund balance of the CSA 34D Fund 0830 to fund the added operational costs; and

WHEREAS, said monies are not included in the adopted appropriations of the FY 2017-18 Budget for CSA 34D, Org 9323; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax Collector is authorized to increase the appropriations in the FY 2017-18 appropriations in the CSA 34D, Org 9323 as follows:


