11 WHEREAS, the Sheriff-Coroner Organization (Org) 3111 will receive \$100,000 as
12 Operating Transfer In from the Sheriff-Coroner Special Revenue Fund 0095, Federal Asset
13 Forfeiture Org 1459 to purchase office furniture to complete phase two; and

14 WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and
15 estimated revenues of the Sheriff Organization 31113000; and

16 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
17 these funds by a four-fifths vote of the Board of Supervisors;

18 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
19 is authorized to increase the appropriations in the FY 2017-18 Sheriff Organization 31113000 as


