WHEREAS, the Aid to Adoptions will receive \$724,585 in Federal funds and \$135,812 from the Protective Service Subaccount Organization 6210; and

WHEREAS, the remaining \$273,222 will be funded with available fund balance in the General Fund from the Aid to Families with Dependent Children - Foster Care Organization 6410 estimates; and

WHEREAS, the \$1,133,619 is not included in the FY 2017-18 adopted appropriations and \$860,397 is not included in the FY 2017-18 estimated revenues of the 2017-18 Aid to Adoptions Organization 6415; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Aid to Adoptions Organization as follows:
