WHEREAS, the County of Fresno will receive \$2,166,390 from the State for an increase in cost attributed to the implementation of Continuum Care Reform; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Aid to Families with Dependent Children- Foster Care Organization 6410; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Aid to Families with Dependent Children- Foster Care Organization 6410 as follows:




