WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Organization 1120 will receive \$2,890,975 in State and Federal funds to meet the need as an Operating Transfer Out to both Aid to Adoptions Org 6415 and Aid to Families with Dependent Children Foster Care Org 6410; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Welfare Advance Fund Organization 1120 as follows:


