WHEREAS, the Interest and Miscellaneous Expenditures Org 2540 requires an increase in appropriations in the amount of \$190,312 to fund costs associated with the reimbursement of prior year Assessor Property Tax Administration Program Fund encumbrances; and

WHEREAS, the Interest and Miscellaneous Expenditures Org 2540 will fund an Operating Transfer Out in the amount of \$190,312 to the Assessor-Recorder Special Revenue Fund 0035, Property Tax Administration Program (PTAP) Org 1040; and

WHEREAS, \$190,312 of Unassigned Fund Balance is available in the General Fund 0001 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations of the Interest and Miscellaneous Expenditures Org 2540; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Interest and Miscellaneous Expenditures Org 2540 as follows:


