WHEREAS, \$437,471 is not included in the adopted appropriations and estimated revenues of the Sheriff-Coroner's ORG 3111 for the Fiscal Year 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the fiscal year 2017-18 appropriations of the Sheriff-Coroner's Org 3111 as follows:


