WHEREAS, the District Attorney-Public Administrator will receive \$81,965 from the Rural Crime Prevention program; and

WHEREAS, \$81,965 is not included in the adopted appropriations and estimated revenues of the District Attorney Grants ORG 2862 for the Fiscal Year 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the fiscal year 2017-18 appropriations of the District Attorney-Grants Org 2862 as follows:


