  - FY 2018-19 \$10,649,818, FY 2019-20 \$18,248,104, FY 2020-21 \$24,645,766, FY 2021-22 \$30,572,397, FY 2022-23 \$37,462, 302. Total 5 year =\$121,578,386. Actual costs will be determined by actual services performed.
- 4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.
  - FCSS shall eventually include many/all school disctricts and schools within Fresno County for mental health treatment and prevention and early intervention services. FCSS acts as a umbrella agency for other school districts and schools to received needed services.

  - When the contract is with a federal, state, or local governmental agency.
  - When the department head, with the concurrence of the Purchasing Agent, finds that the cost of preparing and administering a competitive bidding process in a particular case will equal or exceed the estimated contract amount or \$2,500 whichever is more.
  - When a contract provides only for payment of per diem and travel expenses and there is to be no payment for services rendered.
  - When obtaining the services of expert witnesses for litigation or special counsel to assist the County.
  - When in unusual or extraordinary circumstances, the Board of Supervisors or the Purchasing Agent/Purchasing Manager determines that the best interests of the County would be served by not securing competitive bids or issuing a request for proposal.
- 6. Explain why the unique qualities and/or capabilities described above are essential to your department.
  - Fresno County Department of Behavioral Health is colloborating with the Fresno County Superintendent of Schools to provide integrated mental health and support services to all students in preschools and schools and families in Fresno County. These services are essential to provide for the expansion of adequate and timely access to behavioral health services at all school sites with mental health professionals located on site at the various schools.

  - FCSS acts as an umbrella government agency encompassing many of the school districts and schools within Fresno County. FCSS shall undertake the licensing and certification processes to be an organizational mental health provider in accordance with the Department's Managed Care Mental Health Plan (MHP) guidelines as a medi-cal provider.
