WHEREAS, the Office of the District Attorney-Grants, Organization (Org) 2862 has the opportunity to purchase three vehicles for use during investigations related to the Welfare Fraud program in the current year; and

WHEREAS, the District Attorney-Grants, Org 2862 also has funds available through the inter-departmental agreement with DSS to support welfare fraud investigations and prosecutions involving crimes against DSS' CalWORKS and CalFresh programs in the amount of \$101,000; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$101,000 as an Operating Transfer In from District Attorney-Grants, Org 2862 to purchase the vehicles; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 ISD - Fleet Services Equipment Org 8911 as follows:


