IN THE AMOUNT OF \$162,000)

WHEREAS, the Facility Services, Organization (Org) 8935, requires additional funds in the amount of \$162,000 to be used for the replacement of the roof in the Agriculture Commissioner building located at 1720 S. Maple, Fresno, CA 93702 in the current year; and

WHEREAS, said additional costs will be financed by revenue from Agriculture, Org 40101005 in the amount of \$162,000; and

WHEREAS, Agriculture, Org 40101005 has funds available for the payment of the roof replacement in the amount of \$162,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 Facility Services, Org 8935 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2017-18 Facility Services, Org 8935 as follows:


