NOTICE TO BIDDERS / SUMMARY PROJECT DESCRIPTION (Public Contract Code § 22037): **CONTRACT NUMBER: 17-28-C ASHLAN AVENUE & VAN NESS BOULEVARD INTERSECTION IMPROVEMENTS.** Sealed proposals will be received at the Fresno County Department of Public Works and Planning (Department), Office of the Design Engineer, Seventh Floor, Fresno County Plaza Building, 2220 Tulare Street, Fresno, CA 93721 until 2:00 P.M., (1400 hours and 00 seconds) Tuesday, April 10, 2018, at which time the bidding will be closed. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code Section 4104, shall not be qualified to bid unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work without proof of current registration with the Department of Industrial Relations pursuant to Labor Code Section 1725.5 to perform public works. The work to be done consists, in general, of installing Americans with Disabilities Act compliant concrete curb ramps, constructing concrete curb medians along Ashlan Avenue, removing trees, relocating driveway approaches, widening the intersection, removal and replacement of asphalt concrete pavement, installing curb and gutter, placing area lights, flashing LED pedestrian crossing signs, controller, electrical service equipment, conduits, and wiring. An additive bid item for embedded river rock surfacing in the median landscaping area is also included. An encroachment permit and a traffic control plan must be applied for and accepted by the City of Fresno. This project is anticipated to be awarded by the Board of Supervisors on June 5, 2018. As detailed in Section 8-1.04B, working days for this project shall commence to be counted on July 2, 2018. A limited duration (14 calendar days) of full road closure will be allowed.
