

#### SUMMARY OF ORDINANCE

This Ordinance amends the Fresno County Master Schedule of Fees, Charges and Recovered Costs by amending Section 3800-General Services, revising subsections 3804, and 3809 through and including 3813 therein, relating to the recovery of costs of certain services provided by Fleet Services, Security Services, and Facility Services of the Internal Services Department (ISD) to County departments and other public agencies.
