

NOTICE is hereby given that at its regularly scheduled meeting on June 5, 2018, the Fresno County Board of Supervisors adopted Ordinance No. 18-009, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
This Ordinance amends the Fresno County Master Schedule of Fees, Charges and Recovered Costs by amending Section 4300 - Information Technology Services, in its entirety, revising fees relating to the recovery of costs for information technology services and PeopleSoft Operations provided by the Internal Services Department (ISD) to County departments and other public agencies, wherein subsections 4301 through and including 4315, 4317, and 4319 through and including 4329 are revised.
