D'Andra,

As previously discussed during Fresno County's "Pre-Construction Meeting" for the subject Project, Integrated Water Services, Inc.'s (Contractor; "IWS") listed electrical subcontractor, Prousys, Inc., has withdrawn from the Project. Per the attached Prousys e-mail, Prousys' withdrawal from the Project is due to their inability to bond the Project and other project workload limiting their ability to support this Project.

Due to relatively short notice from Prousys of their withdrawal, IWS intends to self-perform the Project's electrical procurement and construction in order to meet the Project schedule and to manage our costs within our budget for the electrical work.
