1. Fully describe the product(s) and/or service(s) being requested.

The Department of Social Services (DSS) is seeking a vendor to provide a software/database to assist Child Welfare staff locate the most appropriate placement for a foster youth within the vicinity of their current neighborhood and school. The software/database should help expedite the identification and selection of available county foster homes, Foster Family Agency homes and/or residential care facilities to best meet the need of the foster youth experiencing a home change.

3. What is the total cost of the acquisition? If an agreement, state the total cost of the initial term and the amounts for potential renewal terms.

\$4,300 for a 12 month term effective July 1, 2018 - June 30, 2019. No renewal term.

4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.

In 2012, the Department was awarded a four year grant from the Stuart Foundation to participate in the Education Equals Initiative. The Education Equals Initiative seeks to improve educational outcomes for children in foster care. As part of the grant agreement, the Stuart Foundation provided funding and strongly encouraged the Department to use the School Connect web-based database created by the Sacramento County Office of Education, as a tool consistent with the goals of the grant. Although grant funding has ended, DSS desires to continue access of the database. The database helps match foster youth with foster homes located in the same area which will allow the youth to remain in their same school. The database also provides features not currently available to staff, including: map-based searches that identify all homes within a school's vicinity; 24/7 online access; searches by home type; and comprehensive home profiles.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.

In addition to being able to locate a foster home within the foster youth's current school area, the enhanced search engine also assists in matching a placement with the child's needs including interest, medical challenges, and social needs. The system includes over 100 different search filters that can be used to optimize the placement of foster children. The reduction of school changes for foster youth is expected to improve educational outcomes as school displacement has been shown to be a factor in lowering foster youth's educational performance. Use of School Connect is consistent with the Department's effort to improve educational outcomes for youth in foster care.

7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.

Sacramento County Office of Education is a governmental agency and meets the criteria of Administrative Policy #34. Internet research was conducted and there is no other vendor that can provide the School Connect database as this is proprietary to SCOE. Failure to contract with SCOE for the School Connect database will make it more difficult to place foster youth within the vicinity of their current school. It is in the best interest of the County to contract with SCOE for the use of the database.
