

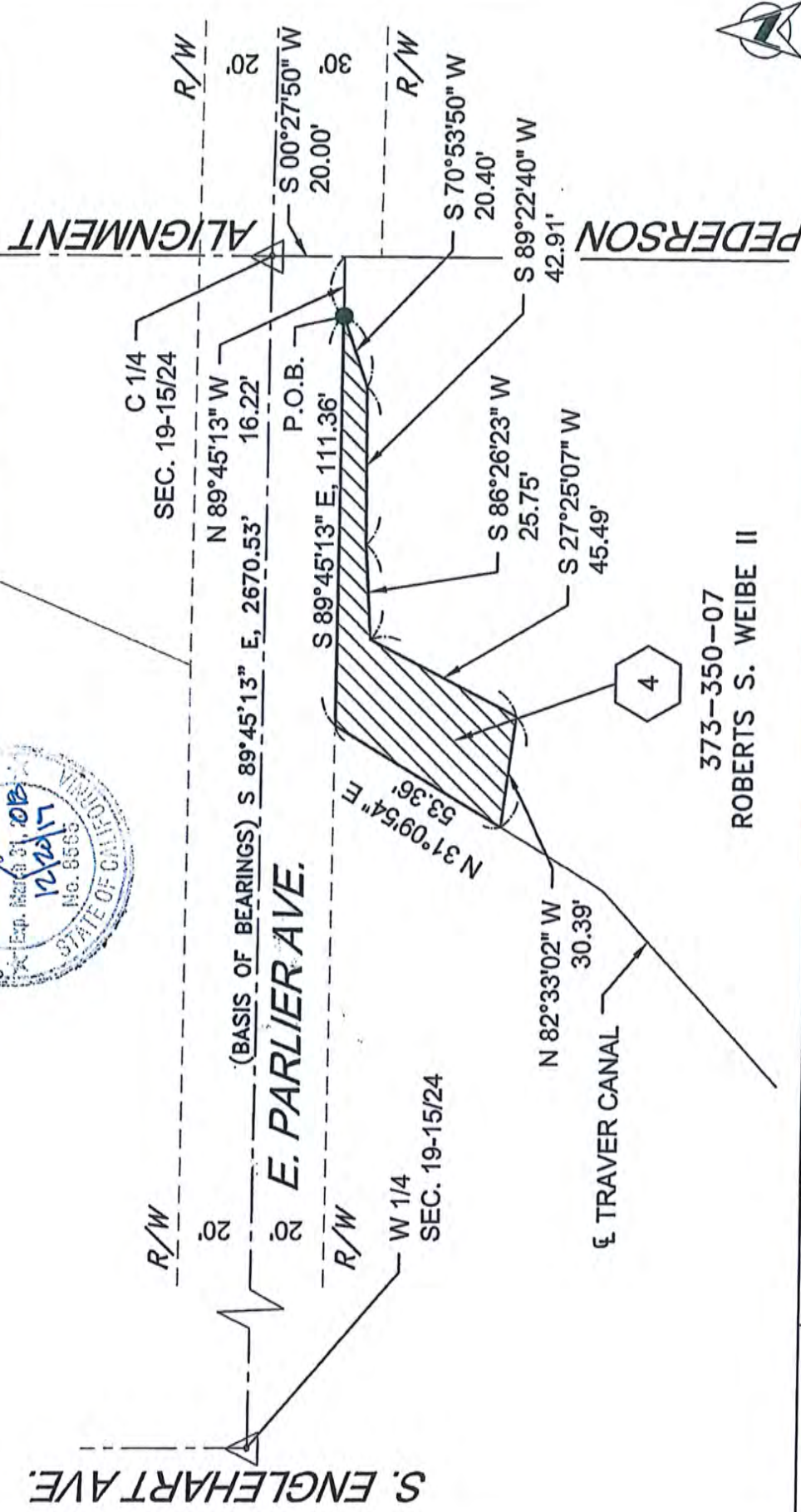
RIGHT OF WAY

PARCEL 4

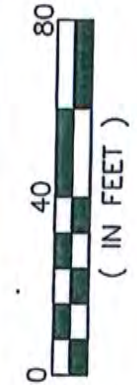

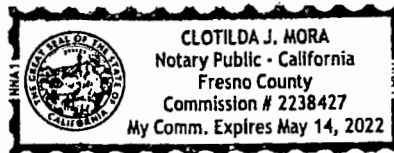
