WHEREAS, the County of Fresno supports continued Federal investment in local infrastructure and workforce training programs that target economic development and training in communities experiencing higher levels of poverty and chronically high unemployment while matching the requirements of growing and emerging industries; and

WHEREAS, the current House Resolution 2 (HR 2) Farm Bill, significantly underfunds SNAP Employment and Training services.

NOW THEREFORE, BE IT RESOLVED that the County of Fresno Board of Supervisors supports Congressional efforts to secure legislation in HR 2 that maximizes Federal revenues that improve access to services and assist families in successfully becoming self-sufficient; including efforts to expand the existing SNAP Employment and Training funding to the maximum extent and providing counties with local decision-making authority over the use of Federal funds; as well as including support for funding to address human service needs which expand economic opportunities for low and moderate income individuals and whole family support services including continued funding for the
