1	AMENDMENT I TO AGREEMENT	
2	THIS AMENDMENT I TO AGREEMENT, hereinafter referred to as Amendment I, is made	
3	this <u>21st</u> day of <u>August</u> , 2018, by and between the COUNTY OF FRESNO, a political	
4	subdivision of the State of California, hereinafter referred to as the "County", and the CITY OF	
5	REEDLEY, hereinafter referred to as the "City".	
6	WITNESSETH	
7	WHEREAS, the County has been designated as the sponsoring agency to administer and	
8	implement the Community Development Block Grant (CDBG) Program activities of the County,	
9	and its participating cities, in accordance with the provisions of Title I of the Housing and	
10	Community Development Act of 1974, as amended, and the laws of the State of California; and	
11	WHEREAS, on March 6, 2018, the County and the City entered into Agreement 18-071,	
12	hereinafter referred to as the "Agreement", whereby \$241,730 in CDBG funds were made available	
13	to the City for the Reedley City Street Improvements, Phase VIII, Project No. 17571, hereinafter	
14	referred to as the "Project"; and	
15	WHEREAS, the City now has an additional \$92,859 from its allocation of CDBG funds that	
16	may be made available to the Project to reduce the City's local fund commitment under the	
17	Agreement; and	
18	WHEREAS, the City has requested these additional CDBG funds in the amount of \$92,859	
19	be made available to the Project for the purposes of this Agreement.	
20	NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the	
21	City and the County agree to amend the Agreement as follows:	
22	1. That the text on Page 1, Lines 14 through 19 be amended to read:	
23	"WHEREAS, the total cost of the Project is estimated at \$775,650 and the City has	
24	committed local funds to the Project in the amount of \$441,061 and is in need of \$334,589 in CDBG	
25	funding to complete the Project; and	
26	WHEREAS, the County can make available \$334,589 in CDBG funds needed for the	
27	Project from the City's 2018-2019 CDBG allocation (\$92,859), from the City's 2017-2018 CDBG	
28	allocation (\$224,231), and from the City's remaining balance of CDBG funds (\$17,499); and"	

1	2. That the proposed funding summary on Page 3, Lines 3 and 4 be amended to read:
2	"CDBG \$334,589
3	Local Financial Contribution441,061Total\$775,650"
4	3. That the dollar figure set forth on Page 2, Line 28, Page 3, Line 16, and Page 4,
5	Line 18, be amended in each such place to read "\$334,589".
6	All remaining provisions, terms, covenants, conditions, and promises contained in said
7	Agreement, dated March 6, 2018, shall remain in full force and effect.
