AMENDMENT I TO AGREEMENT

THIS AMENDMENT I TO AGREEMENT, hereinafter referred to as Amendment I, is made this <u>21st</u> day of <u>August</u>, 2018, by and between the COUNTY OF FRESNO, a political subdivision of the State of California, hereinafter referred to as the "County", and the DEL REY COMMUNITY SERVICES DISTRICT, hereinafter referred to as the "District".

WITNESSETH

WHEREAS, the County has been designated as the sponsoring agency to administer and implement the Community Development Block Grant (CDBG) Program activities of the County, and its participating cities, in accordance with the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and the laws of the State of California; and

WHEREAS, on August 8, 2017, the County and the City entered into Agreement 17-427, hereinafter referred to as the "Agreement", whereby \$250,000 in CDBG funds were made available to the District for the Del Rey Emergency Generators and Sewage Grinder, Project No. 16151, hereinafter referred to as the "Project"; and

WHEREAS, the District informed the County that the total estimated cost of the Project has increased from \$250,000 to \$410,560 due to increased construction costs; and

WHEREAS, the County now has an additional \$160,560 of CDBG funds that can be made available to the Project to accommodate the increased construction costs; and

WHEREAS, the District has requested these additional CDBG funds in the amount of \$160,560 be made available to the Project.

NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the District and the County agree to amend the Agreement as follows:

1. That the proposed Project budget on Page 2, Lines 21 through 23 be amended to read:

2. That the proposed funding summary on Page 3, Lines 3 and 4 be amended to read:
