WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Library Grants Organization 7517 as follows:


