ASSIGNMENT OF AGREEMENT

Ramco Services and Pacific Water Technologies, a California corporation, whose address is 2401 East Orangeburg Ave. #675, Modesto, CA 95355, ("ASSIGNEE").

WITNESSETH:

10 WHEREAS, COUNTY and ASSIGNOR entered into Agreement No. 16-452, dated July 12, 2016 ("AGREEMENT") pursuant to which ASSIGNOR agreed to provide chemical treatment 12 services for the COUNTY's HVAC systems at various COUNTY-owned facilities; and

WHEREAS, SECTION 8 - NON ASSIGNMENT of the AGREEMENT provides for the assignment of the Agreement with the written consent of both Parties; and

WHEREAS, ASSIGNOR wishes to assign, transfer, and delegate all of its rights, benefits, benefits, responsibilities, and obligations under the AGREEMENT to ASSIGNEE; and

WHEREAS, ASSIGNEE represents that s/he is willing and qualified to accept the assignment, transfer, and delegation of ASSIGNOR'S rights, benefits, responsibilities, and obligations under the AGREEMENT, and to perform faithfully and completely in ASSIGNOR's stead thereunder.

NOW, THEREFORE, the parties agree that the AGREEMENT shall be, and is, transferred and assigned by ASSIGNOR to ASSIGNEE as follows:

23 ASSIGNOR does hereby transfer and assign all of its rights, interest, obligations, 1. 24 and responsibilities under the AGREEMENT to ASSIGNEE.

25 2. ASSIGNEE does hereby accept from ASSIGNOR the Assignment of the 26 AGREEMENT and ASSIGNEE agrees, without qualification or reservation of right, to perform each 27 and every one of ASSIGNOR'S obligations and responsibilities under the AGREEMENT and 28 adhere to all terms of the AGREEMENT, as though ASSIGNEE were the signatory party of said

10	further payments are owed by COUNTY to ASSIGNOR.
