1. Fully describe the product(s) and/or service(s) being requested.

The Department of Social Services (DSS) is seeking a California Department of Education approved Alternative Payment Program (APP) provider to administer voucher disbursement services on behalf of families involved in the Emergency Child Care Bridge Program for Foster Children (Bridge Program). DSS is participating in the Bridge program and are authorized by the California Department of Social Services (CDSS) to enter solely into an agreement with a Fresno County designated APP provider for the provision of voucher distribution services.

3. What is the total cost of the acquisition? If an agreement, state the total cost of the initial term and the amounts for potential renewal terms.

The total cost of the acquisition is \$1,885,602 over the cumulative term of the agreement and \$628,534 over each one (1) year potential renewal term. This includes the estimated value of issued vouchers and administrative cost. The initial term of the agreement for these services will be effective November 1, 2018 through June 30, 2019 and will include two (2) optional one (1) year renewals.

4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.

Participation in the Bridge program requires the administration and issuance of over \$600,000 in child care voucher subsidies. DSS seeks to contract for these services and are restricted by CDSS directive to contract only with a State-approved APP county provider. There are two (2) APPs, Central Valley Children's Services Network (CVCSN) and Supportive Services, Inc., that provide services within the County of Fresno. Participation in the Bridge Program also requires DSS to contract specifically with CVCSN, as they are the only State designated Resource and Referral (R&R) agency in the county. These components involve child care navigator services and caregiver training. These services are strongly intertwined with the child care voucher issuance component. As such, it is deemed to be in the county's best interest to suspend competition and contract with CVCSN for voucher distribution. CVCSN will be familiar with Bridge-participating families as well as involved child care providers. Overall, the use of CVCSN for voucher disbursement services will support greater efficiency by contracting all Bridge components with one agency instead of multiple.

5. Identify from Administrative Policy #34 what circumstances constitute a Suspension of Competition.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.

Without an APP, DSS will be responsible for coordinating payment for child care services. It is cost beneficial to contract for these services, and will not divert staff resources to administer payments for such a large-scale project. CDSS acknowledges this internal administrative burden and has allowed counties participating in the Bridge Program the option to utilize APPs for this purpose.

7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.

CVCSN and Supportive Services, Inc. are the only CDE approved APPs in Fresno County.
As the State designated R&R agency, CVCSN is the only vendor able to provide all the necessary components of the Bridge Program.
