RESOLUTION

WHEREAS, \$4,388,998 funding is needed to complete improvement projects for the Adult Detention Facility for the FY 2018-19 Jail Improvements Org 8852; and

WHEREAS, the Interest and Miscellaneous Expenditures Org 2540 will fund an Operating Transfer Out in the amount of \$4,388,998 to the Capital Projects Fund 0400, Jail Improvements Org 8852; and

WHEREAS, \$4,388,998 of Unassigned Fund Balance is available in the General Fund 0001, Subclass 10000, to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations of the Interest and Miscellaneous Expenditures Org 2540; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Interest and Miscellaneous Expenditures Org 2540 as follows




