
Permission is hereby granted to enter upon my land for the above stated purpose within that area shown outlined on the map attached hereto and made a part hereof by reference.

The term of this PERMIT TO ENTER shall commence when construction begins, and shall terminate upon completion of the LEACH FIELD RECONFIGURATION AND GRADE MATCH, or two years thereafter, whichever comes first; provided, however, that, in the event construction is not completed after two years, the term of this PERMIT TO ENTER shall be extended by written approval of the OWNER.

Upon completion of the above-described work, the property is to be left in a reasonably neat and clean condition.





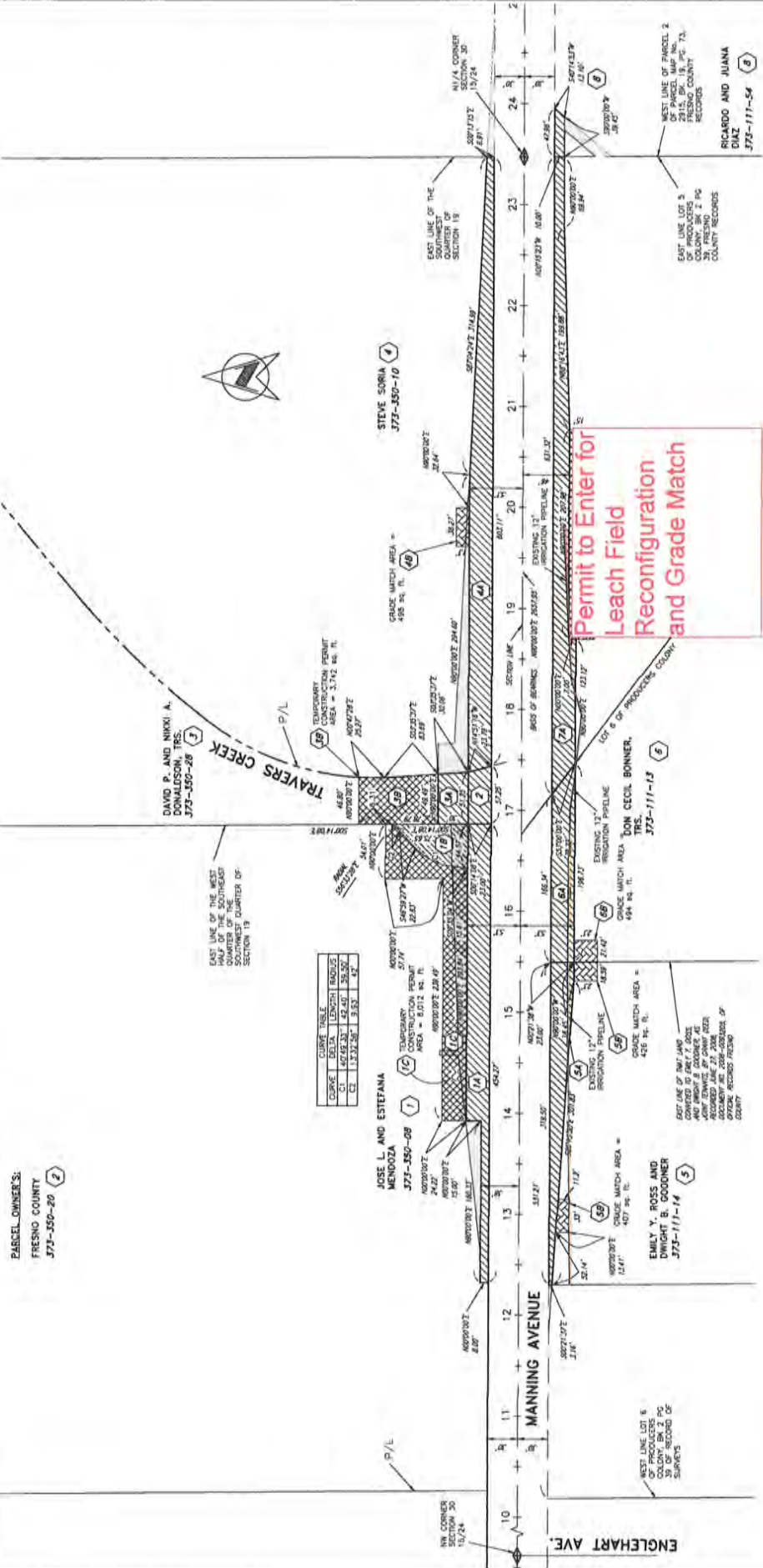
