11	WHEREAS, at the conclusion of the public hearing, the Fresno County Planning Commission		
12	recommended approval of GPA No. 552 and Rezone No. 3825; and		
13	WHEREAS, the Board duly fixed September 11, 2018, for a public hearing on the amendment		
14	of the County General Plan and the public hearing was held thereon in the manner prescribed by law;

16	WHEREAS, the Board considered the Agenda Item with attachments including the Planning		
17	Commission Staff Report, the proposed amendment, and the Planning Commission's resolution; and		
18	WHEREAS, the Board heard and considered verbal and/or written public testimony on the		
19	proposed amendment; and		
20	WHEREAS, at the conclusion of public testimony the Board voted to continue the matter to the		
21	October 23, 2018 hearing to allow the project applicant additional time to meet with community		
22	residents on their concerns related to the proposal; and		
23	WHEREAS, at its October 23, 2018 hearing the Board considered the Agenda Item with		
24	attachments including the Planning Commission Staff Report, the proposed amendment, and the		
25	Planning Commission's resolution; and		
26	WHEREAS, the Board heard and considered additional verbal and/or written public testimony		
27	on the proposed amendment; and		

1	WHEREAS, the amendment of the General Plan consists of re-designating the land use of two		
2	adjacent parcels totaling 4.15 acres from Rural Density Residential to Limited Industrial to allow an		
3	animal hospital/shelter and related uses; and		
4	WHEREAS, on the basis of the whole record before the Board of Supervisors, including any		
5	comments received, there is no substantial evidence that this amendment to the General Plan will have		
6	a significant effect on the environment; and		
7	WHEREAS, this will be the first amendment cycle to the Fresno County General Plan in this		
8	calendar year.		
9	NOW, THEREFORE IT IS HEREBY RESOLVED that the Fresno County Board of Supervisors		
10	hereby adopts Resolution amending the Fresno County General Plan as proposed by GPA No. 552.
