RESOLUTION

WHEREAS, Assembly Bill 109 (Chapter 15, Statutes of 2011) Public Safety Realignment funds are available to add appropriations and estimated revenues for the District Attorney's Adult Compliance Team (ACT) to purchase one investigator vehicle; and

WHEREAS, the District Attorney Org 2860 will receive \$45,000 as an Operating Transfer In from the Special Revenue Fund, Local Community Corrections Org 3436; and

WHEREAS, the District Attorney Org 2860 will fund an Operating Transfer Out in the amount of \$45,000 to the Internal Services Department, Fleet Services-Equipment Org 8911 for the purchase of the vehicle; and

WHEREAS, \$45,000 is not included in the adopted appropriations and estimated revenues of the District Attorney Org 2860 for FY 2018-19; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the appropriations in the FY 2018-19 District Attorney Org 2860 as follows:


