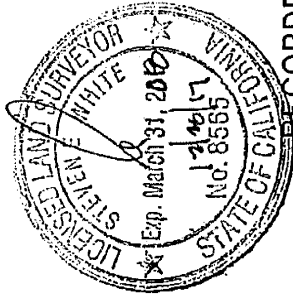

TO COUNTY OF FRESNO

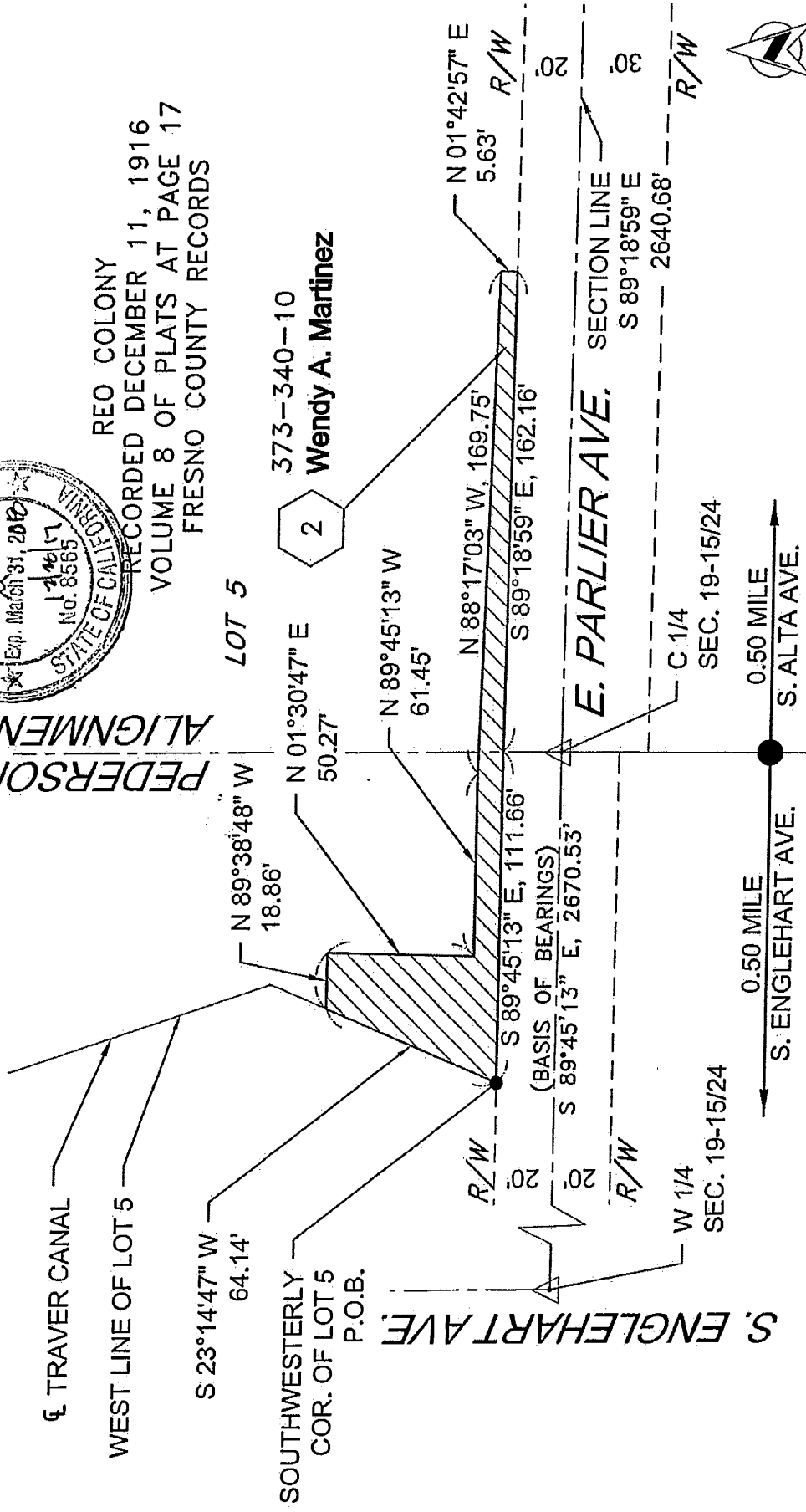



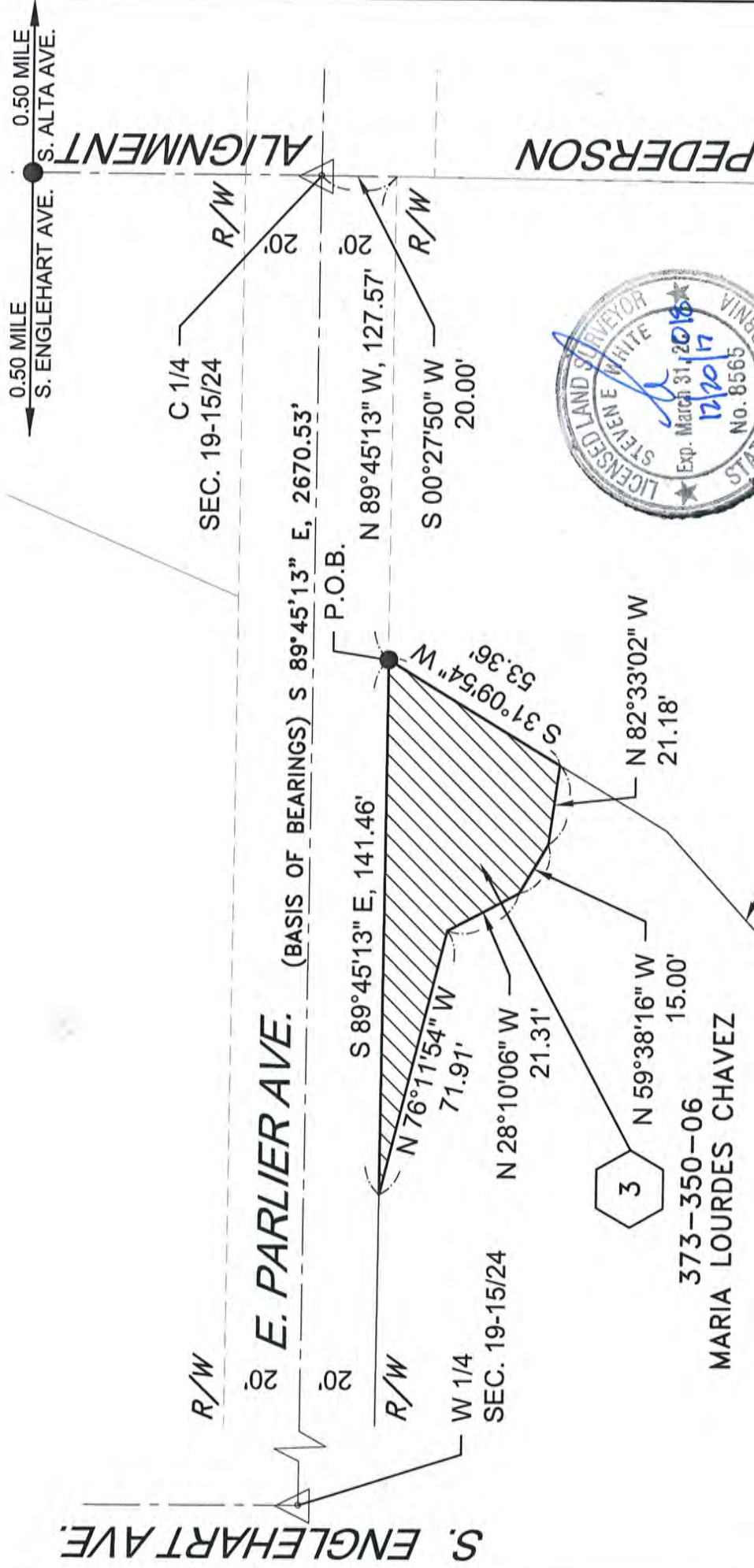
