IN THE AMOUNT OF \$750,000.)

WHEREAS, the County of Fresno has been awarded a grant award in the amount of \$750,000 for FY 2018-19, FY 2019-20 and FY 2020-21 from the California Department of Finance (DOF) under the State Supplementation for County Assessors' Program (SSCAP) to assist County Assessors in performing property assessments; and

WHEREAS, the awarded grant funds in the amount of \$750,000 will be deposited into a special Revenue Fund and then transferred to the Department's Org in the General Fund; and

WHEREAS, funds in the amount of \$750,000 are not included in the FY 2018-19 adopted appropriations and estimate revenues of the SSCAP Grant Organization 1049 Subclass 17059; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2018-19 appropriations for the SSCAP Grant Organization 1049 Subclass 17059 as follows:




