WHEREAS, the Active Transportation Program provides grant funds for eligible local agencies for the purposes of increasing the proportion of biking and walking trips, increasing safety and mobility for non-motorized users, advancing the efforts of regional agencies to achieve greenhouse gas reduction goals, enhancing public health and addressing childhood obesity; and

WHEREAS, the County of Fresno (County) applied to the 2019 Active Transportation Program Cycle 4 for funding of various ATP projects on July 31, 2018; and

WHEREAS, the County, the Fresno County Board of Supervisors, wishes to express: 1) its commitment to and support of the ATP and the projects the County submitted in the related 2019 ATP Cycle 4 call for projects; 2) its approval of the underlying program of projects, as expressed in the ATP applications the County submitted to the 2019 ATP cycle 4; and 3) its dedication to delivering the projects as programmed and by the deadlines that will be later agreed upon between the County and FCOG and/or other governmental agencies, if and when the projects receive funding.

NOW THEREFORE BE IT RESOLVED, that the Fresno County Board of Supervisors hereby expresses:

1) its commitment to, and support of, the ATP and the projects the County submitted in the related 2019 ATP Cycle 4, ATP applications;

2) its approval of the underlying program of projects, as expressed in the ATP applications the County submitted to the 2019 ATP Cycle 4; and

1 3) its dedication to delivering the projects as programmed and by the deadlines that will
2 be later agreed upon between the County and FCOG and/or other governmental
3 agencies, if and when the projects receive funding.


