6 AN ORDINANCE AMENDING THE ORDINANCE CODE OF THE COUNTY OF FRESNO BY  
7 ADDING PARAGRAPH "M" TO SECTION 2.52.040 OF CHAPTER 2.52. ADDING PARAGRAPH "M"  
8 TO SECTION 2.52.040 OF CHAPTER 2.52 PROVIDES THAT THE DIRECTOR OF THE  
9 DEPARTMENT OF PUBLIC WORKS AND PLANNING IS AUTHORIZED TO AND SHALL ACCEPT,  
10 ON BEHALF OF THE BOARD OF SUPERVISORS, ROADS OR PORTIONS THEREOF, INTO THE  
11 COUNTY ROAD SYSTEM AND TO RECORD CONVEYANCES TO THE COUNTY OF REAL  
12 PROPERTY INTERESTS FOR ROAD USES AND PURPOSES, ALL IN ACCORDANCE WITH THE  
13 PROVISIONS OF CALIFORNIA STREETS AND HIGHWAYS CODE SECTION 941(d).

14 The Board of Supervisors of the County of Fresno does ordain as follows

15 SECTION 1 The Ordinance Code of the County of Fresno is hereby amended by ADDING  
16 PARAGRAPH "M" TO SECTION 2.52.040 OF CHAPTER 2.52, which Paragraph "M" reads as follows  
17 "M. Accepts, on behalf of the Board of Supervisors, roads or portions thereof, into the county road  
18 system and records instruments of conveyance to the County of real property interests for road uses  
19 and purposes, to which the Director shall affix, prior to such recording, a certificate stating the  
20 acceptance into the county road system and designating the name or number, or both, of the county  
21 road, all in accordance with the provisions of California Streets and Highways Code Section 941(d).

22 SECTION 2: This ordinance shall take effect and be in full force and effect thirty (30) days from  
23 and after its passage.




