WHEREAS, a vacancy exists in the Fresno County Board of Supervisors effective December 3, 2018; and

WHEREAS, the Charter of the County of Fresno, Section 8.(b) requires the Board of Supervisors to call a special election in the event that a Board vacancy occurs prior to the final year of the term of the Board member; and

WHEREAS, the term of office for the vacated position is 2019 through 2020; and
WHEREAS, the Charter of the County of Fresno, Section 8.(b) states that the special
election to fill such vacancy is to be held not less than seventy-five nor more than ninety days
after the call, provided, however, if an election date as provided in the Elections Code falls not
less than seventy-five nor more than one hundred twenty days after the call, the special election
shall be consolidated with such election; and

WHEREAS, the person appointed or elected to fill such vacancy shall serve for the remaining unexpired term and until the election and qualification of his successor; and

WHEREAS, a person appointed or elected must be a qualified elector of the district in which the vacancy occurs, must have been a resident of the territory therein for at least thirty days immediately preceding the appointment, or immediately preceding the date of filing nominating papers or equivalent declaration of candidacy for the election for which he is a candidate, and must reside therein during his incumbency.
