ORDINANCE NUMBER _____

AN ORDINANCE AMENDING CHAPTER 13.28 OF THE ORDINANCE CODE OF THE
COUNTY OF FRESNO, "LEASING OF COUNTY PROPERTY" AND RENAMING THAT
CHAPTER, "LEASING OR LICENSING OF ANY REAL PROPERTY BELONGING TO, LEASED
BY, OR LICENSED BY THE COUNTY."

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1. That Chapter 13.28 of the Ordinance Code of the County of Fresno is hereby
renamed, "Leasing or Licensing of Any Real Property Belonging to, Leased by, or Licensed by
the County."

Section 2. That Section 13.28.010 is hereby amended to read as follows:

13.28.010 – Alternative procedures

~~"~~The county shall follow the procedures set forth in this chapter, when applicable, for the leasing
and licensing of any real property belonging to, leased by, or licensed by the county ("county
real property") instead of the formal bidding procedures set forth in Government Code Sections
25526 et seq. For purposes of this chapter, a "lease" of county real property shall include any
"sublease" of county real property, as well."~~"~~

Section 3. That Section 13.28.030 of the Ordinance Code of the County of Fresno is hereby
amended to read as follows:

1 **13.28.030 – Leases and licenses excluded from bidding procedures.**

2 ~~“~~A. At the discretion of the county administrative officer, or his/her designee, a lease or license
3 of any county real property of a duration not exceeding five (5) years and having an estimated
4 monthly rental not exceeding five thousand dollars (\$5,000) may be excluded from the formal
5 bidding procedures of Government Code Sections 25526 et seq., and 25537(a), as well as the
6 informal bidding procedures set forth in Section 13.28.020 above. If excluded from these bidding
7 procedures, the lease or license shall be let pursuant to this section.

8 B. The county administrative officer, or his/her designee, shall negotiate in the name of the
9 county as lessor or licensor of the excluded lease or license. Notice of the letting of the lease or
10 license shall be provided pursuant to Government Code Section 25537(b) and (d). The term of
11 the executed lease or license shall not exceed five (5) years and shall not be renewable. The
12 actual monthly rental set forth in the executed lease or license shall not exceed five thousand
13 dollars (\$5,000) per month.

14 C. A lease or license of county real property of a duration not exceeding ten (10) years and
15 having an estimated monthly rental not exceeding thirty-five thousand dollars (\$35,000) may be
16 excluded from the formal bidding procedures of Government Code Sections 25526 et seq. and
17 Section 25537(a), as well as the informal bidding procedures set forth in Section 13.28.020
18 above, so long as the County is entering into the lease or license to enable the lessee or
19 licensee to provide a service to, or for the benefit of, the County, the state, or any local public
20 agency. Notice of the letting of the lease or license shall be provided pursuant to Government
21 Code Section 25537(b). The term of the executed lease or license shall not exceed ten (10)
22 years and shall not be renewable. The actual monthly rental set forth in the executed lease or
23 license shall not exceed thirty-five thousand dollars (\$35,000) per month. A lease or license

24 entered into pursuant to this Section 13.28.030(C) must be approved and executed by the board
25 of supervisors.

Section 3. That Section 13.28.040 of the Ordinance Code of the County of Fresno is hereby amended to read as follows:

13.28.040 - Authority to execute lease and licenses.

A. The county administrative officer, or his/her designee is authorized to execute leases and licenses let pursuant to Sections 13.28.020 and 13.28.030(A) and (B) above. Such authority shall expire on December 31, 2023.

B. The county administrative officer, or his/her designee, shall provide written notice to the supervisor for the district in which the county real property proposed to be leased or licensed is located, as required by Government Code Section 25537(c)(3), prior to executing a lease or license pursuant to ~~this chapter~~ Sections 13.28.030(A) or (B). Such written notice is deemed received upon personal delivery to the supervisor's office or three days after mailing, postage paid, in the U.S. mail. If the supervisor objects in writing to the proposed lease or license within fifteen working days of receipt of the notice, the lease or license shall be submitted for approval by the board of supervisors at a regular meeting.

Section 2: This ordinance shall take effect thirty (30) days after final passage.
