8               WHEREAS, the County Clerk-Elections Org 2850 requires an increase in appropriations in  
9 the amount of \$250,000 to fund special election costs related to filling the vacated District 2 seat in  
10 the Fresno County Board of Supervisors; and

12               WHEREAS, \$250,000 of Unassigned Fund Balance is available in the General Fund 0001 to  
13 fund these expenditures; and

14               WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations of the  
15 County Clerk-Elections Org 2850; and

16               WHEREAS, Section 29130 of the Government Code provides for the appropriation of these  
17 funds by a 4/5ths vote by the Board of Supervisors;

18               NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector  
19 is authorized to increase the appropriations in the FY 2018-19 County Clerk-Elections Org 2850 as  
20 follows:


