8	of a traffic engineering study, has recommended that NO STOPPING signs be installed on
9	Shaw Avenue between Third Street and Biola Avenue (West), because the signs are necessary
10	to properly indicate and carry out the provisions of the Vehicle Code, necessary to guide traffic,
11	necessary to prevent motorists from obstructing traffic, and necessary to protect pedestrian
12	safety and pedestrian paths of travel.
13	NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors
14	does authorize the installation of NO STOPPING signs on Shaw Avenue between Third Street
15	and Biola Avenue (West), to properly indicate and carry out the provisions of the Vehicle Code,
16	to guide traffic, and to prohibit motorists from bringing vehicles to a complete stop upon the
17	highway, which impedes or obstructs the normal and reasonable movement of traffic and
18	jeopardizes pedestrian safety and paths of travel, unless the stop is necessary for safe
19	operation or in compliance with law.
20	NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors
21	directs the Director of the Department of Public Works and Planning to erect NO STOPPING
22	signs in a manner not inconsistent with this resolution.
