He was Ag Commissioner/Sealer in Modoc County, Ag Commissioner/Sealer in Kings County and Chief Deputy Agricultural Commissioner in Fresno County before his appointment as Fresno County Ag Commissioner/Sealer of Weights & Measures on August 5, 2013; and

**WHEREAS**, Commissioner Wright holds a degree in Production Agriculture and had his first government job at a border inspection station in 1976. He is considered an expert among his peers in all things related to noxious weeds, the gray wolf and predator control; and


