

Extension of an Interim Urgency Ordinance pursuant to Government Code Section 65858, made applicable to all Zoning Districts of the Fresno County, continuing a moratorium on the possession, planting, cultivation, harvesting, drying, or processing of nonmedical cannabis outdoors on the grounds of a private residence and the establishment or operation of a business engaged in commercial cannabis activity. Extension of the Interim Ordinance would be effective for a period of up an additional 10 months and 15 days (to December 5, 2019) unless earlier terminated.



### SUMMARY OF ORDINANCE

Extension of an Interim Urgency Ordinance of the Board of Supervisors of the County of Fresno continuing a moratorium on the possession, planting, cultivation, harvesting, or processing of nonmedical cannabis outdoors on the grounds of a private residence and the establishment or operation of a business engaged in commercial cannabis activity in all zoning districts of Fresno County for up to an additional 10 months and 15 days.
