As you know, United Health Centers of San Joaquin Valley submitted an application to the CMFA to be its Issuer of tax-exempt financing for a project located throughout the County of Fresno. The project is expected to be financed in amount not to exceed \$30,000,000 of tax-exempt revenue bonds. The proceeds of the Bonds will be used to: 1) finance the construction of a new approximately 20,000 square foot comprehensive health center to be located at 2022 East Manning Avenue, Reedley, California; 2) refinance the outstanding California Municipal Finance Authority Insured Revenue Bonds; 3) refinance a 2015 New Market Tax Credit loan; and 4) finance renovations to the health center located at 650 South Zediker Avenue, Parlier, California.
