WHEREAS, Since becoming Senior Pastors in Sanger, Pastor Ed and Bethel Church have served the families of Fresno County through food distribution, thousands of children have received backpacks full of school supplies to prepare them for school, hundreds of children have received fully paid summer camp scholarships throughout the Central Valley and more importantly the message of Christ has been preached; and

WHEREAS, In February 2019 Ed and Meredith Forsythe will celebrate their 10 year Anniversary as Senior Pastors for Bethel Church. Pastor Ed and Meredith Forsythe have not only served the Bethel Church congregation, but they have served as East Fresno District Presbyters for the Pentecostal Church of God Central California District and the residents of Fresno County.

**NOW THEREFORE, BE IT RESOLVED** that the Fresno County Board of Supervisors hereby proclaim February 10, 2019 as "Pastor Ed and Meredith Forsythe Day" in Fresno County, in recognition of their 10 year anniversary as Senior Pastor for Bethel Church and in appreciation for their steadfast commitment to serve the families of Fresno County.
