CERTIFICATE OF TENTATIVE CANCELLATION

(less than the total of the land subject to contract)

NOTICE IS HEREBY GIVEN:

By resolution dated February 12, 2019, the Board of Supervisors of the County of Fresno granted tentative approval of the petition by Jack E. Williams, III, for Ceres Ranch No. 4 LLC, for partial cancellation of Agricultural Land Conservation Contract (ALCC) No. 3726 for residential use, which applies to the real property situated in the County of Fresno, State of California, and is more particularly described on the legal description attached as Exhibit "A", and made a part hereof, describing an approximately a 1.50-acre portion of an 18.86-acre parcel subject to cancellation.

The above-referenced parcel is less than the total of the real property subject to ALCC No. 3726.

A Certificate of Cancellation of the Contract shall be issued and recorded at such time as the following contingencies and conditions are satisfied:

1. The landowner shall obtain the necessary Parcel Line Adjustment resulting in an adjusted 1.50-acre parcel and combine the 17.36-acre balance of the subject parcel with

1 an adjoining 39.49-acre parcel resulting in a separate 56.85-acre adjusted parcel. Further, as  
2 the existing 18.86-acre parcel is enrolled in the Program under Contract No. 3726 and the  
3 existing 39.49-acre parcel is also enrolled in the Program under Contract No. 8302, a  
4 Rescission and Re-entry of the Williamson Act Contracts is required to reflect the boundaries  
5 of the adjusted contracted parcel; and


6 2. The applicant shall pay the Cancellation Fee in the amount of \$5,625.00 as  
7 determined by the County Assessor and certified by the Board of Supervisors for issuance of  
8 a Certificate of Cancellation by the Board. The Cancellation Fee shall be paid and a  
9 Certificate of Cancellation issued prior to Recordation of the Parcel Line Adjustment.
