13 Trafficking Areas Interdiction revenue to offset expenditures associated with the addition of the

16 estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31116377; and

17 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
18 these funds by a four-fifths vote of the Board of Supervisors;

19 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
20 is authorized to increase the appropriations in the FY 2018-19 Sheriff-Coroner-Public
