WHEREAS, County Information Technology Analyst IV Lori Fleenor, retired on December 17, 2018; and

WHEREAS, Lori Fleenor has been an Information Technology Analyst IV in Applications and Programming; and

WHEREAS, Lori Fleenor has the unique knowledge of the Property System migration to Megabyte which makes her critical to the on-going implementation of the County's new property tax system; and

WHEREAS, Government Code section 7522.56 requires a one-hundred eighty (180) day separation period, as established by the California Public Employees' Pension Reform Act, unless the employer's governing body finds and certifies the nature of the employment and that the appointment is necessary to fill a critically needed position before the one-hundred eighty (180) day separation period has passed.

NOW, THEREFORE, BE IT RESOLVED, that the Fresno County Board of Supervisors hereby adopts this Resolution to hire extra-help retiree Lori Fleenor on an as-needed basis, effective February 25, 2019, finding and certifying that the provisions of Government Code section 7522.56 requiring a one-hundred eighty (180) day separation period for retired employees returning to employment as extra-help are not applicable to Ms. Fleenor, because of the nature of Ms. Fleenor's employment and that her appointment is necessary to fill a critically-needed position before 180 days has passed following the date of Ms. Fleenor's retirement.
