RESOLUTION

WHEREAS, the District Attorney Organization (Org) 2860 has the opportunity to purchase four (4) investigator vehicles for use in the District Attorney's Bureau of Investigations; and

WHEREAS, the District Attorney, Org 2860 also has funds available through salary savings in the amount of \$188,400; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$188,400 as an Operating Transfer In from the District Attorney, Org 2860 to purchase four vehicles; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2018-19 Fleet Services-Equipment Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Fleet Services-Equipment Org 8911 as follows:


