The Department seeks to implement a pilot home visiting program for California Work Opportunity and Responsibility to Kids (CalWORKs) participants within the existing contracted network of neighborhood resource centers (NRCs) to complement the work already taking place to support positive health, development, and well-being outcomes for eligible pregnant and parenting women, families, and infants born into poverty.

Total cost of the 17-month Agreement is \$4,235,000 with no renewal terms.
4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.
Goals of the home visiting service include reducing instances of child maltreatment, improving parent-child interactions, and promoting self-sufficiency, which directly align with the programs offered by the currently contracted NRCs. The Department seeks to leverage the infrastructure already procured and fold the home visiting service into the array of services provided by the NRCs.

By adding the home visiting service to the existing infrastructure of NRCs, both Child Welfare and CalWORKs populations can access valuable child abuse prevention, intervention, and self-sufficiency supports while building resources within their immediate neighborhoods.
