13	Code, § 31450 et seq.) and the Public Employees' Pension Reform Act of 2013
14	("PEPRA," Gov. Code § 7522 <i>et. seq.</i>);
15	WHEREAS, the Board of Supervisors of the County of Fresno (the "County Board of
16	Supervisors") has not heretofore adopted Government Code § 31458.4 allowing a FCERA
17	Member's ex-spouse ("alternate payee") who is receiving or is entitled to receive payments from
18	FCERA pursuant to a court order dividing the community property interest in the FCERA
19	Member's retirement allowance to designate one or more beneficiaries to receive those payments
20	following the death of the alternate payee;
21	WHEREAS, Government Code § 31458.4 states among other things that if there is
22	no designated beneficiary by the alternate payee, payment shall be made to the estate of
23	the alternate payee;
24	WHEREAS, Government Code § 31458.4 authorizes the County Board of
25	Supervisors to adopt, by resolution, and make the provisions of Government Code §
26	31458.4 applicable in Fresno County;
